The Context of the conference

None the less, the above inhuman practices need to be addressed in all walks of life and all means needs to be explored to protect and promote human rights in our society.

Human rights education is considered as an important defender of human rights. Its only through human rights education, training and awareness, we can develop a human rights conscious and sensitive society. Human rights education is argued as an integral part of the right to education and is increasingly gaining recognition as a human right in itself. Knowledge of rights and freedoms is considered a fundamental tool to guarantee respect for the rights of all. Education should encompass values such as peace, non-discrimination, equality. justice, non-violence, tolerance and respect for human rights and dignity. Quality education based on a human rights approach means that rights are implemented throughout the whole education system and in all learning environments. The United Nations 'World Programme for Human Rights Education (2005-ongoing)'following the achievements of the United Nations Decade for Human Rights Education(1995-2004), seeks to promote a common understanding of basic principles and methodologies of human rights education. This Programme goes beyond the human rights education in school systems to encompass human rights training for teachers, educators, civil servants, law enforcement officials, military personnel, media professionals, journalists, etc.

Moreover, human rights education is a vital component of the right to education which again is an integral part of rights to life, under Article 21A of Indian Constitution. The RTE Act, 2009 opened new possibilities and posed challenges for promoting human rights education.

It is in this backdrop, RIE, Bhubaneswar (a constituent unit of NCERT) is planning to hold this two day National Conference with a purpose to develop all possible means and ways to promote human rights education.

- The length of the paper should be between 3,000 to 4,000 words excluding references; references should be given at the end of the paper in APA style.
- Page Layout: Paper should be submitted in MS Word format, Font type: Times New Roman, Font size: 12 points, Line spacing: 1.5 lines.
- A screening committee will shortlist the abstracts based on originality and quality of research under various themes and authors of these will be informed accordingly. Please adhere to the time schedule given below.
- The abstracts and full papers will be published in the proceedings of the conference.
- A few selected papers will be published with ISBN number by a reputed publishing house.
- Abstract and full papers shall have to be sent to politicalscienceseminar2017@gmail.com


About RIE, Bhubaneswar
